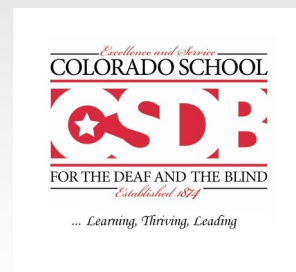

Who are we?



The Colorado Hearing Resource (CO-Hear) Coordinator is a trained professional who works with children who are Deaf or Hard of Hearing and their families. The CO-Hear Coordinator is knowledgeable about state and local systems specific to young children with hearing loss, which include, but are not limited to Child Find, EI Colorado, local Community Centered Boards, Health Care Program for Children with Special Needs (HCP) and resources within the family's community. The CO-Hear works closely with agencies and organizations to support the needs of each family.

What is our role?

The CO-Hear Coordinator provides unbiased information that empowers parents to make informed decisions for their child.

CO-Hear Coordinator services are an optional service offered to all families in Colorado with children newborn to age 3) who are Deaf or Hard of Hearing.

- Information about the Colorado Home Intervention Program (CHIP)
- Representation at Individualized Family Service Plan (IFSP) meetings
- Support developing a language plan
- Technical and emotional support
- Educational materials
- Consultation with school district staff during the child's transition to preschool (starting at 2 1/2 years of age)
- Joint consultation with professionals providing services to the family
- Opportunities to meet adults who are Deaf or Hard of Hearing
- Information about statewide events and activities
