The Colorado Hearing Resource (CO-Hear) Coordinator is a trained professional who works with children who are Deaf or Hard of Hearing and their families. The CO-Hear Coordinator is knowledgeable about state and local systems specific to young children with varied hearing levels. These include Early Intervention (EI) Colorado, Local Early Intervention Programs, Child Find, and resources within the family's community. The CO-Hear Coordinator works closely with agencies and organizations to support the individualized needs of each family.

What is Our Role

The role of the CO-Hear Coordinator is to provide unbiased and comprehensive information to parents, empower them to make informed decisions for their child, and support them in their decisions.

CO-Hear Coordinator services are offered to all families in Colorado with children from birth to age 3 who are Deaf or Hard of Hearing.

What We Provide

- Information about Early Intervention (EI) Colorado and Part C Services
- Information about the Colorado Home Intervention Program (CHIP)
- Representation at the Individualized Family Service Plan (IFSP) meetings
- Support developing a language plan
- Educational and information materials
- Opportunities to meet adults who are Deaf or Hard of Hearing
- Connections to other agencies and organizations who can support the family
- Information about statewide events and activities
- Consultation with school district staff during the child's transition to preschool (starting at 2 years 3 months old)
